A MESSAGE FROM THE CEO



In 2021, Hamilton County residents approved a 0.95 mil levy, which enabled Great Parks to make significant strides in achieving the public's vision for the future of our parks. The levy helps fund key projects like the Sharon Woods Playground, Woodland Mound Fitness Equipment, Miami Whitewater Forest 240-acre land acquisition, and the Music Garden at Glenwood Gardens.

In coordination with the 2021 levy, Great Parks also launched the 10-year Go Big! Capital Campaign, with an ambitious \$50 million goal to help reduce reliance on tax dollars and to privately fund major capital projects. We are proud to share that less than halfway into our Go Big! Capital Campaign, we have achieved over 40% of the goal. We have also prioritized seeking outside public funding, through state and federal grants, allowing us to secure more than \$56 million in alternative funding. This support is essential in advancing \$100 million in critical infrastructure and \$124 million in park improvements identified during our master planning process.

Looking ahead to 2025, we're excited to continue delivering on our promises. Current projects underway include the Glenwood Gardens to Winton Woods Shared-Use Trail, Bass Island River Access, Shaker Trace Nursery improvements, and the West Region Blueway and Trail System, plus so much more that will contribute to making our region a premier outdoor destination for all to enjoy. One of the most significant projects in Great Parks' history, the Sharon Lake Improvement Project, will be completed in late 2025 with a full opening in Spring 2026.

Thank you for your partnership in advancing our region as a better place to live, learn, work, and play.

Conservation is core to Great Parks' mission. It ensures the long-term health and sustainability of natural resources, ecosystems, and biodiversity within Hamilton County. Great Parks' dedicated team of natural resource management professionals ensures native plants, animals, and habitats are protected for generations to come. Preserving natural areas allows for continued recreational and environmental education opportunities and promotes mental and physical well-being for guests.

85% of land managed by Great Parks is protected as undeveloped natural space.

WINTON WOODS **Outdoor Adventure Expo Expansion**

Great Parks expanded this popular event to two days to provide more opportunities for guests to find their wild. While preserving the Kids Outdoor Adventure Expo mission to provide outdoor recreation opportunities to underserved children, the Outdoor Adventure Expo added 5k and 10k competitive races and offered more opportunities for adults and families to enjoy climbing, rafting, fishing, vendors, food, and more!



Pollinator Festival

Great Parks hosted the inaugural Pollinator Festival and 5k Race, a special event focused on celebrating all the great things pollinators, like bees, butterflies, bats, and birds, allow us to do. The event included local vendors with pollinator-themed items, a 5k race, and special Great Parks Pollinator Festival merchandise to celebrate its inaugural year.









Great Parks offered special viewing sites for the 2024 total solar eclipse, including a full viewing celebration at Miami Whitewater Forest, the only Great Parks location in the path of totality. Satellite locations were also set up at Sharon Woods and Winton Woods about how animals act during an eclipse, food trucks, and special

Culvert Repair

Great Parks maintains critical infrastructure around Hamilton County to provide safe access for guests to parks, trails, and more. In 2024, one of the many critical infrastructure projects completed was the Columbia Connector Culvert Repair project to provide improved access to the Columbia Connector Trail above it. The project entailed replacing aging infrastructure with new materials to improve the critical stormwater drainage system.

SHARON WOODS

Sharon Lake Improvement Project

Great Parks began the \$13.6 million renewal of Sharon Lake, one of its largest projects, aimed at enhancing recreation, wildlife habitat, and natural access. Beginning in April, the 35-acre lake was drained to optimize depth, create new wetlands, and add rock weirs, a boardwalk, a fishing pier, and an accessible kayak launch. The project addresses public priorities from the Comprehensive Master Plan, such as improving ecological resilience and expanding access, and is expected to be completed in late 2025 with a full opening in spring 2026.









Sharon Woods Destination Playground

Great Parks opened a \$3 million, 10,000-square-foot destination playground at Sharon Woods in September. The nature-inspired playground includes bird nest play structures, a crayfish climber,



dragonfly wobble boards, and features reflecting the park's wildlife and nearby creek. Designed with input from the public, it is accessible to children of all abilities. More than 500 guests attended the grand opening, featuring free snow cones, games, animal encounters, and lots of smiling faces.









LOOKING AHEAD TO 2025 & BEYOND

Mitchell Memorial Forest Skills Loop & Skills Course

The Mitchell Memorial Forest Skills Loop & Skills Course will provide opportunities for beginner and novice mountain bikers to practice balance on the track while testing out new skills additions along the trail. The new amenities will open in late 2025.

Avoca Trailhead Improvements

Great Parks looks forward to fully opening the new 1.5-mile mountain bike trail at Avoca Trailhead, which includes formalizing the natural surface trail with views of the Little Miami River and improving access for adaptive mountain biking. This will be the first in a braided network of mountain bike trails planned along the river and the Little Miami Scenic Trail.

In its third year, Great Parks' annual holiday celebration, Holidays on the Farm, partnered with Keep Cincinnati Beautiful to display inCANdescent. Built from hundreds of reused paint cans, inCANdescent was designed by artists with Keep Cincinnati Beautiful for the 2024 Blink celebration. The installation is a fitting symbol of Great Parks' and Keep Cincinnati Beautiful's shared focus on improving the quality of life for all who live and work in the region.

Great Parks + HighGrain Mural

Great Parks and HighGrain Brewing share a vision as community gathering spaces and environmental stewards working to create a sustainable future for Hamilton County and the greater Cincinnati region. Launched in November, the Great Parks Mural at HighGrain Brentwood showcases the vibrant plant and animal life found throughout Great Parks' 22 destinations. An interactive, digital mural was launched simultaneously and is found on GreatParks.org. The mural celebrates our shared commitment to *Protect* natural spaces, *Connect* with our community, and *Explore* the great outdoors.

PROTECTING PARKS & PEOPLE

The Great Parks Rangers are state-certified law enforcement officers who exercise full police powers and work for the protection of guests, the conservation of parks and wildlife, and the enforcement of state laws and park by-laws. The Rangers patrol all 22 destinations and over 18,000 acres of land by cruiser, UTV, boat, bike, and on foot 24 hours a day, year-round. Their in-depth knowledge of the parks and surrounding communities allows them to provide a safer and more welcoming experience for all guests. In 2024, the Rangers participated in 25 community events and hosted four special events for Hamilton County residents.

Green Team Expands

In 2024, Great Parks hosted two Green Teams, a program that cultivates high school students for employment readiness within the green industry. PLANTING THE SEEDS OF CHANGE

As the philanthropic partner for Great Parks, Great Parks Forever stewards natural and financial resources for all, forever. In 2022, Great Parks Forever launched the Go Big! Capital Campaign to raise \$50 million to leverage public funds. In 2024, Great Parks Forever raised more than \$1 million in private donations and more than \$13 million in committed grants to support the numerous projects and programs that foster a deeper connection between the community and the natural world.

Record-Breaking OKI Grant

Great Parks was awarded \$8 million from the OKI Regional Council of Governments for phase one construction of the Oasis Trail – the largest grant in Great Parks' history. This crucial trail expansion will be a 4.75-mile paved, shared-use trail for cyclists, runners, and walkers that safely connects downtown Cincinnati to Lunken Airport and the 78-mile Little Miami Scenic Trail.



Farmer Family Foundation Match

Through June 30, 2025, the Farmer Family Foundation is matching every gift, up to \$2 million to the Go Big! Capital Campaign. By the end of 2024, Great Parks reached more than 40% of this goal! This generous gift encourages community involvement and support for the ambitious goals outlined in our Comprehensive Master Plan.





FINANCIALS

STEWARDING PUBLIC FUNDS

Thank you to the voters of Hamilton County, who in November 2016, passed a 10-year 1.0 mill replacement levy, and in November 2021, passed a 10-year 0.95 mill levy to support critical infrastructure needs and park and facility master plan projects. These funds allow Great Parks to maintain existing facilities and amenities, provide ongoing recreation and wellness opportunities, preserve and protect over 18,000 acres, and build and maintain trails across the region. Additional funding leveraged by earned revenue activities, programming, and events, along with state and federal grants and donor-generated private funding from Great Parks Forever, helps support the priorities of the 10-year Comprehensive Master Plan.
