## **REGULAR MEETING**

## GENERAL

- 1. PUBLIC COMMENTS: No one requested to address the Board.
- 2. AWARDS & RECOGNITIONS:

Mr. Burwinkel and Ms. Wegman attended the Mill Creek Alliance's Canoes and Conservations Event on June 17 and commented on their great experience at the event. Mr. Burwinkel and Ms. Wegman attended the Auditor of State of Ohio Audit Exit Conference on July 18 and congratulated the Finance staff for their excellent work on the audit. Ms. Wegman thanked the Glenwood Gardens staff for hosting her aunt's garden club. Ms. Wegman attended the West Region Blueway and Trail System open house on Thursday, July 13, and noted the event was excellent.

Chief Executive Officer Todd Palmeter notified the Board of the following:

- Kids Outdoor Adventure Expo was held at Winton Woods Harbor on Friday, July 14, with an estimated attendance of over 6.000. Over 20 additional Great Parks staff attended this portion of the meeting and were recognized for their hard work and dedication to the children of Hamilton County. The Board expressed their sincere appreciation to the staff.
- Talent Development Specialist Nathan Davis was presented a Certificate of Merit by Chief Executive Officer Todd Palmeter and Ranger Chief Scott Snow in recognition of his quick and assertive actions towards rescuing a child that had fallen into Winton Lake on July 14, 2023, during the Kids Outdoor Adventure Expo.

- Chief of Marketing and Brand Strategy Rachel Doellman introduced new employee Suzi Poat, Community Engagement Coordinator.

4. RESOLUTION #3768 – BILLS & PAYROLL RESOLUTION: Chief Executive Officer Todd Palmeter presented the Bills & Payroll Resolution to the Board. The Board submitted two payment items for review from St. Gregory Group Inc. for marketing and advertising. The staff led a thorough discussion, providing clarifying information on marketing campaigns, printed materials, and the metrics for measuring the impact of digital marketing. Upon motion duly made by Abrams, seconded by Wegman, the Board approved the Bills & Payroll Resolution. The Roll Call vote was as follows: Mr. Abrams – Aye, Mr. Burwinkel – Aye, Ms. Laverty – Aye, Ms. Wegman – Aye.

- 5. RESOLUTION #3769 BUDGET ADJUSTMENT: Chief Financial Officer Andrew Collins presented the Budget Adjustment Resolution to the Board. The staff led a thorough discussion, providing clarifying information on transferring funds from unused salaries to capital purchases. Upon motion duly made by Wegman, seconded by Burwinkel, the Board approved the budget adjustment as presented in the resolution. The Roll Call vote was as follows: Mr. Burwinkel – Aye, Ms. Laverty – Aye, Ms. Wegman – Aye, Mr. Abrams – Aye.
- APPROVAL OF MINUTES: Upon motion duly made by Abrams, seconded by Wegman, and unanimously carried, the Board approved the Final Minutes of the Regular Board Meeting of June 15, 2023.
- 7. BID TAB SHARON WOODS GOLF COURSE IRRIGATION PHASE 2 TRANSFER PUMP AND FORCE MAIN PROJECT: Chief Executive Officer Todd Palmeter presented the bid tab to the Board. The staff led a thorough discussion, providing clarifying information on the use of the reservoir, the source of water when Sharon Lake is dredged, and the project scope. Upon motion duly made by Abrams, seconded by Wegman, and unanimously carried, the Board awarded a contract in the amount of \$903,300 to Smith Corp Inc. for the Sharon Woods Golf Course Irrigation Phase 2, Transfer Pump and Force Main Project.
- 8. RESCIND APPROVAL OF BID FLEET VEHICLES: Chief Executive Officer Todd Palmeter presented the rescindment to the Board. The staff led a thorough discussion, providing clarifying information on the reasons for the rescindment and the reallocation of funds. Upon motion duly made by Burwinkel, seconded by Abrams, and unanimously carried, the Board rescinded the bid to Feldman Ford for one Compact Cargo Van, two ½-Ton Crew Cab Pickup Trucks, four ¾-Ton Crew Cab Pickup Trucks, and one 4x2 Stainless Body Dump Truck in the total amount of \$279,459.
- 9. RESCIND OF BID TAB MODIFICATION FLEET VEHICLES: Chief Executive Officer Todd Palmeter presented the rescindment to the Board. The staff led a thorough discussion, providing clarifying information on the reasons for the rescindment and specifications of the vehicles. Upon motion duly made by Abrams, seconded by Wegman, and unanimously carried, the Board rescinded the bid tab modification of the October 20, 2022, approval of the bid to Feldman Ford for the purchase of four Hybrid Gasoline/Electric Hatchbacks and the three Compact Transit 6-Passenger Vans in the amount of \$211,855.

#### MONITORING REPORTS

10. FINANCIAL CONDITION & ACTIVITIES: Chief Financial Officer Andrew Collins presented the Financial Conditions & Activities report. The staff led a thorough discussion, providing clarifying information on the timing of revenue projects versus revenue received and interest rates. Mr. Burwinkel inquired about the capital improvement schedule mentioned in the tax levy, Great Parks' value to the community, and the next economic impact study. Ms. Laverty commented about inflationary increases. After a thorough discussion, the Board determined the report to be reasonable and acceptable. The Board then ordered the report filed for the record.

- 11. FRIENDS OF THE WHITE WATER SHAKER VILLAGE RICH SPENCE: President of the Friends of the White Water Shaker Village, Rich Spence, addressed the Board. Mr. Spence's presentation included information on the North Family Dwelling Complex and Friends of the White Water Shaker Village organization and site restoration projects. Ms. Laverty complimented the restoration and upgrades. She inquired about their funding and operating overhead. After a thorough discussion, the Board determined the report to be reasonable and acceptable. The Board then ordered the report filed for the record.
- 12. PHILANTHROPY DIVISION REPORT: Chief Executive Officer Todd Palmeter presented the Philanthropy Division report to the Board. The Board ordered the report filed for the record.
- 13. PURCHASING CARD COMPLIANCE OFFICER: Chief Executive Officer Todd Palmeter presented the Purchasing Card Compliance Officer report to the Board, reporting compliance. The Board ordered the report filed for the record.
